

Introduction of the School Safety and Insurance Federation(SSIF)

Basis of establishment

Established by the Minister of Education for efficiently performing both the preventive undertaking of a safe school and the school safety insurance undertaking according to Article 28 of the [Prevention and Compensation of the Safety Accident in School].

purpose of establishment

- To prevent safety accidents occurred in course of education activities.
- To rapidly and properly compensate damages that students, teaching staffs and participants in education activities suffer on account of safety accidents in school.

Introduction of the compensation and aid insurance system for the school safety accident

The insurance system for compensating to students, teaching staffs and participants in the education activities who suffer from damages to their life or physical body due to school safety accident in course of education activity according to the [Act for Prevention and Compensation of the Safety Accident in School]

Education activity

- In-school/Out-of-school curriculum activity under the management/supervision of a school head according to education curriculum (education plan).
- Participation activity in the event (mass meeting) that the school head admits.
- Activity in course of go-to-school/out-of-school, school stay, job experience, work experience, dormitory life and travel time.

School safety accident

- All accidents occurred in course of education activity that cause physical damages to students, etc.
- Disease such as food poisoning or sunstroke, etc. directly caused by the management/supervision by the school head.

Type of aid benefits

Medical care benefits	Payment of treatment expenses due to accident
Disablement allowances	Paid when disablement remains after closing treatment
Nursing allowances	Payment of nursing expenses against the Disablement Class I, II
Benefits for the bereaved	Paid when the patient dies
Funeral expenses	Paid when the patient dies
Compensation expenses	Paid when the patient dies due to unknown causes in course of education activity
Preservation expenses	Paid when the teaching staff, etc. spends in relation with the school safety accident

Improvement of school safety system



- ▶ Revision of laws & regulations and improvement of system which are related with the school safety.
- ▶ Improvement of school safety policies.
- ▶ Survey/research for the compensation system of school safety aids.
- ▶ Survey/research for establishing the preventive policies against the school safety accidents.
- ▶ Operation of the school safety committee
- ▶ Survey/research for the payment basis of the school safety aid benefits, etc.

Prevention of the school safety accidents



- ▶ Development of education materials for school safety, and execution of related education
- ▶ Operation of the school safety information center (www.schoolsafe.kr)
- ▶ Survey of the actual school safety conditions
- ▶ Contest exhibit for a safe school
- ▶ Operation of the management system of the school-bus for children(schoolbus.ssif.or.kr)

Support for operation of the SSIA



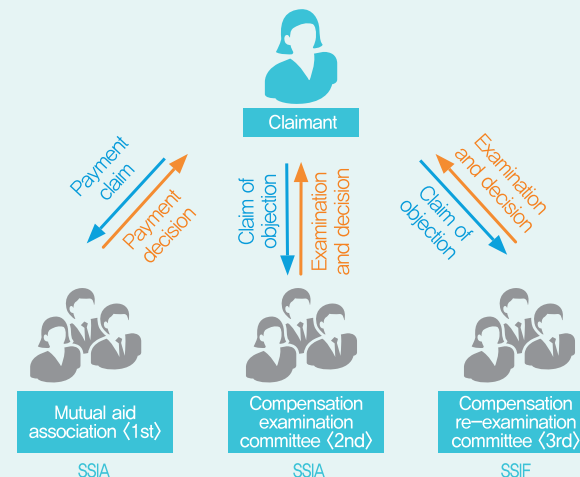
- ▶ Staff education for the school safety aids
- ▶ Provision of law services such as interpretation of laws and regulations
- ▶ Operation of call center (1688-4900)
- ▶ Operation of the aid benefits management system (www.schoolsafe.or.kr)
- ▶ Operation of compensation re-examination committee for school safety aids insurance

Summary of re-examination claim

Object of claim: Case that objection is raised against the decision of examination claim by the examination committee

Claim period: Within 90 days from the date when the original copies for examination claim decisions are sent to the examination requester

Insurance by the School Safety and Insurance Federation



▶ Safety insurance for the Korean school in foreign countries

Compensation object

- Damages caused by death or physical damage that the insurance beneficiary suffers on account of rapid, casual or foreign accidents in course of education activity
- Damages caused by each of following diseases that occur to the insurance beneficiary by direct business which management/supervision of the school head such as school meal service is belonged to.
 - Poisoning/sunstroke by school meal service or gas, etc.
 - Disease by intake of foreign materials, etc.
 - Skin infection by contact with foreign materials
 - Disease directly caused by outside shock and injury

▶ School compensation liability

Compensation object

- Personal, physical damages that the third party suffers due to education activities
- Personal, physical damages by defect of a 'child play facility
- Damages caused by loss of student belongings under supervision by the school
- Fines imposed to the school head in relation with school meal services

▶ Safety insurance for juvenile activities

Compensation object

- Damages related with life, body and property that occurred by a safety accident in course of juvenile training activities
- Personal, physical damages caused to the third party by the aid beneficiary due to defect in a 'Child Play Facility'

▶ Consulting committee for consultation support, etc.

Compensation object

- Any costs required for the consultation and psychological treatment should be performed by the organization designated via examination by a consulting committee.
- Any costs required for the consultation and psychological treatment should be borne by the Minister of Education via examination of the consulting committee within a year after starting such consultation and treatment.
